**2021 UEC Congress**

Dear Presidents,

Further to our correspondence of 27 November 2020, we would like to explain the various electoral procedures planned at the next 2021 UEC Congress.

In accordance with the UEC Constitution articles 13-14-15 and the UCI Constitution, the UEC Management Board is proposing for the elections to be carried out as follows:

- a. Election of the UEC President**
- b. Election of six (6) other UEC Management Board members**  
*Break – checking of voting slips and announcement of results*
- c. Election of the fifteen (15) voting delegates and (8) substitute voting delegates for the UCI Congress.**

*NB: the eight (8) UEC substitute voting delegates will be elected at the same time as the incumbents. The fifteen (15) candidates who have obtained the most votes will be appointed «voting delegates» and the eight (8) following candidates will be appointed «substitute voting delegates».*

- d. Election of the two (2) UEC auditors or appointment of an external auditor**

*Break – checking of voting slips and announcement of results*

*NB: in accordance with Article 13, point 12 – UEC Constitution:  
At the electoral Congress, elections will be held successively in the order stipulated in points a), b), c) and d) from paragraph 1 of the present article. Once he/she is elected, any application of a candidate in another election is declared null and void. If they are not elected, candidates may take part in the next election, provided that they have also applied for this election and have not withdrawn it from the EVCM.*

- e. Election of the 10 European candidates for the UCI Management Committee**

*Break – checking of voting slips and announcement of results*

The applications must be sent to the UEC headquarters, addressed to the electoral and voting monitoring commission (EVMC), by post or e-mail, at least thirty (30) days before the Congress.

**Presentation of the candidates**

The submission of candidatures for the **UEC Presidency and the UEC Management Board** shall be sent along with a curriculum vitae, a brief presentation of the candidate not exceeding two pages and a copy of their 2020 and 2021 licences;

The submission of candidatures for the **voting delegates and substitute voting delegates** for the UCI Congress shall be sent along with a copy of their 2020 and 2021 licences;

The submission of candidatures for the **UCI Management Committee** shall be sent along with a curriculum vitae, a brief presentation of the candidate not exceeding two pages, a copy of their passport and 2021 licence (art. 52 UCI Constitution).
