CHEF DE MISSION

- All participating countries need to appoint a Chef de Mission, responsible for managing the National Federation's Delegation before and during the event.
- Chef de Mission will be a single point of contact for each National Federation, to ensure the correct information is delivered to the relevant teams.
- Chef de Mission will be responsible to escalate any concerns from the 13 Championships Team Managers to the organizers.

Before the Event

- Be the main point of contact for the Federation related to the 2023 UCI Cycling World Championships
- Review and direct communication from the UCI and organisers within the Federation
- Lead the Federation's effort to prepare for the event (accreditation, sport entries, visa applications, appointment and briefing of mission staff – example: appointment of team managers, logistics – hotel and travel bookings, et cetera)
- Attend any future briefings
- Generally, stay up-to-date about the event

During the Event

- Be the main point of contact for the Federation

- Attend any briefings for Chefs de Mission held during the event

FREIGHT

Since the United Kingdom's formal withdrawal from the European Union and the end of the Brexit transitions period on 31 December 2022, the rules for the import of goods from outside the UK from EU countries have changed.

It is strongly recommended that clients use the services of a Licensed Customs Broker who is familiar with the specific import requirements to the UK.

If you are planning on sending items in advance of your arrival, please allow additional time for customs clearance.

RADIO FREQUENCIES

- To use radio equipment in the UK you must apply for a Programme Making and Special Events (PMSE) licence from <u>Ofcom</u> (the regulator of communication services in the United Kingdom).
- It has been noted from previous cycling events held in the UK that team equipment is often operated on frequencies that are not licensable in the UK (as they are the frequencies in use for Emergency Services).
- Equipment may have to be re-programmed, which can take some time. Please submit your frequency applications as early as possible.

VISA TYPES – STANDARD VISITOR VISA

- Applications are considered under the visitor immigration rules
- Applicant must satisfy the decision maker that they will leave at the end of their visit
- Applicant must also demonstrate that they can support and maintain themselves during their visit.

SUPPORTING INFORMATION – VISITOR VISA

Provide evidence that:

- You're coming to do a permitted activity invitation letter from event organiser is essential
- You'll leave the UK at the end of your visit advise the date that you will depart the UK and that you will pay for your return travel
- You're able to support yourself for the duration of your trip know where you
 are staying and visiting during the trip
- Applicants are best placed to determine the documents they think best demonstrate that they meet the Immigration Rules.


VISA – BIOMETRICS

- To complete your application, you need to provide your Biometrics (fingerprints and facial photograph).
- This may involve attending a visa application centre (VAC) operated by one of the UK home office commercial partners.
- It is very important that you enter the country where you would like to provide your biometrics.
- If there is no VAC in your selected country, you will be able to choose an alternative location.
- You will not be able to change the location after you have submitted your application.

VISA APPLICATION PROCESS



APPLICATION ADVISE

- Applications can be made up to three months however you can create a visa application account at any time to pre-enter information.
- Please remember you will be required to attend a biometric appointment so factor this into your timescales
- Current application processing time is 4 weeks from submitting biometrics however this can vary

VISA INVITATION LETTER ONLINE SYSTEM- INTRO

- National Federations can request a VISA invitation letter for their delegates in need of a VISA
- A bespoke VISA invitation letter online system was created to allow the Chef de Missions to provide the needed information on the participating delegates and obtain a VISA invitation letter.
- Due to the fact the letter contains sensitive personal data it will be a PDF that can be downloaded directly from the system.
- The VISA invitation letter cannot be sent by email, due to the UK legislation on data collection.

VISA INVITATION LETTER ONLINE SYSTEM - INTRO

- CdM will receive and individual account login by email
- CdM will need to provide details for each individual traveling to the UK and in need of a VISA:
 - Personal data (Full name, Gender, Country of birth, Country of residence)
 - UKVI Reference Number (GWF, it's the VISA application number generated online when you apply for the individual visa, sent by email)
 - Visa Application Centre (VAC- where the invitation letter be sent to for your biometrics)
 - Passport Number (expiry and place of issue)
 - Travel details (arrival & dept dates)
